Reports

Chair's Report – All is well.

Secretary Report – Keep It Simple group's former GSR (Sue), emailed me ask to be remove her as GSR on the minutes. I'm also sorry that one of the motions was not put in previous minutes.

Treasurer's Report –The balance brought forward of the Area's Treasury on September 17th, 2012 was one hundred fifty-three dollars and nine cents (\$153.09). Three groups, **Clean and Serene** (\$40), **Lost and Found** (\$50.00) and **Turning Point** (\$49) donated a total of one hundred thirty-nine dollars (\$139.00) to the Area. Rent in the amount of ten dollars (\$10.00) for use of our meeting space was given to Dave V., GSR for **Turning Point** Group. On November 19th, 2012 a Cashier's Check in the amount of one hundred

twenty-five dollars and sixty cents (\$125.60) payable to AT&T for the Information Line was secured and mailed. This leaves a balance of one hundred fifty-six dollars and forty-nine cents (\$156.49). AT&T sent statements in October and November of 2012 showing the monthly charge as forty-one dollars and forty-five cents (\$41.45) which leaves us with a credit balance of forty-one dollars and forty-five cents (\$41.45) which will be applied to the bill for December 5th through January 4th, 2013. In the September report I stated that the payment would be made on September 17th. I want to make sure that everyone is aware that I did not intentionally misrepresent my intentions. The cashier's check was not secured until September 19th and the payment was mailed on the same day. This was due to the unexpected death of my mother-in-law on the morning of the 16th.
