Treasurer Report – The balance brought forward of the Area Treasury on March 24th, 2012 was ninety-eight dollars and eighty-nine cents (\$98.89). Two groups **Living with Hope** and **A Gift of Life** donated ten dollars (\$10) each. Rent in the amount of ten dollars (\$10) for use of our meeting space was given to Dave V., GSR for **Turning Point** Group. This leaves a balance of one hundred eight dollars and eighty-nine cents (\$108.89) AT&T sent a bill on April 5th, 2012 showing the monthly charge as forty dollars and twenty cents. This bill covered April 5th through May 4th, 2012. We received a bill today for May 5th through June 4th, 2012 in amount of forty dollars and twenty cents (\$40.20). We now have a credit balance with AT&T of forty-two dollars (\$42.00) which according to currently monthly billing will cover June 5th through July 4th, 2012 (one more billing cycle). I would like for the groups determine if we want to pay monthly or continue to make one or two payments per year. We will also need to keep in mind that we are now paying rent for ASC meeting space out of the Area's treasury.
